

To protect people, plants and animals from dangerous infectious diseases, strict rules are set in the European Union, including Latvia, as to the products and goods the traveller may introduce in the territory of the European Union, and the procedure for the introduction thereof.

When entering Latvia from a non-European Union country, the goods and products in your personal luggage intended for self-consumption, are subject to strict veterinary, phytosanitary or food safety control at the border crossing post.

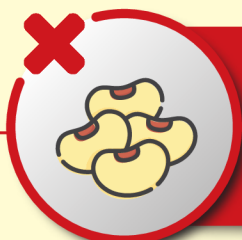
OTHER FOOD PRODUCTS



Private individuals are **ALLOWED TO INTRODUCE** the following in the European Union without limitations

processed products of non-animal origin (for example, food supplements, mineral waters, beverages, etc.);

processed products of plant origin (pickles, juices, dried fruits and unshelled nuts, confectionary products, etc.), except up to 5 kg of fresh products or 2 kg of other products listed in Annexes I and II of Regulation (EU) 2019/1793 and up to 10 kg fresh products or 2 kg other products listed in Regulation (EU) 2020/1158*.



For private individuals it is **PROHIBITED TO INTRODUCE** the following in the European Union

all dried beans originating from Nigeria.

- Republic of Latvia Cabinet Regulation No. 46 of 21 January 2020 "Requirements and Procedure for the Border Control of Such Food and Materials and Products Intended to Come into Contact with Food to be Introduced from Third Countries, which are Exempt from Official Border Control".
- Commission Delegated Regulation (EU) 2019/2122 of 10 October 2019 supplementing Regulation (EU) 2017/625 of the European Parliament and of the Council as regards certain categories of animals and goods exempt from official controls at border control posts, specific controls on passengers' personal luggage and on small consignments of goods sent to natural persons which are not intended to be placed on the market and amending Commission Regulation (EU) No. 142/2011.

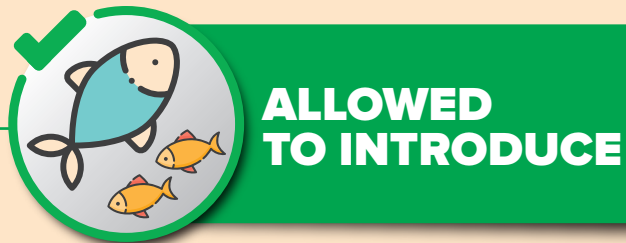
PRODUCTS OF ANIMAL ORIGIN



IT IS PROHIBITED TO INTRODUCE

Meat, meat products (fresh meat, smoked meat products, semi-finished meat products, meat products and processed meat and products containing meat or meat products (meat preparations) for example, dumplings, pizza, etc.).

Milk, milk products (fresh milk, pasteurised milk, condensed milk, cottage cheese, sour cream, cheese and others).



ALLOWED TO INTRODUCE

Fishery products (fresh, dried, thermally processed, salted or smoked fish and certain shellfish species, for instance, shrimps, lobsters, non-live mussels and non-live oysters).

Is allowed to introduce fresh, whole fish and fishery products provided that:

- ✓ fish has been eviscerated;
- ✓ the weight of fishery products per person does not exceed 20 kg or the weight per fish, whichever is higher.



For personal use is **ALLOWED TO INTRODUCE**

- ✓ milk powder for infants, infant food and food for special medical purposes, intended for consumption by the infant during travel and which do not require refrigeration prior to consumption.
- ✓ pet food for medical purposes, intended for a pet accompanying its owner, provided that the product is shelf-stable.

In both cases:

- the product is packaged and company patented;
- the product packing is not damaged, except, if the respective product is being used;
- total quantity per person does not exceed 2 kg;
- total quantity from the Faroe Islands and Greenland does not exceed 10 kg per luggage of one person.

Allowed to introduce products of animal origin in **small quantities** from Andorra, Iceland, Liechtenstein, Norway, San Marino and Switzerland.

PLANTS AND PLANT PRODUCTS



For private individuals it is **PROHIBITED TO INTRODUCE** the following in the European Union

- ✓ quarantine organisms (pests, diseases and disease agents);
- ✓ plants of selected genus and species intended for planting**;
- ✓ potatoes;
- ✓ soil, growing medium, except for clean peat and coconut fibres;
- ✓ biological and chemical plant protection products.



Private individuals are **ALLOWED TO INTRODUCE** the following in the European Union

With a phytosanitary certificate issued by the country of dispatch:

- ✓ plants of various genus intended for planting*;
- ✓ seeds for sowing;
- ✓ fresh, unprocessed plant products (fruits, vegetables, flowers, etc.), inter alia, shelled nuts.



Private individuals are **ALLOWED TO INTRODUCE** the following in the European Union

Without a phytosanitary certificate:

- ✓ bananas, durians, coconuts, dates and pineapples.

It is prohibited to introduce plants referred to in Annex I to Regulation 2020/1201/EU from countries not declared as free from bacteria *Xylella fastidiosa*.
